#### **Article VI: Election of District 02 Officers and Chairpersons: Section 2.00**

**Eligibility:** All members of District 02 are eligible to serve as District Officers and Chairpersons.

The LCMs have usually served as GSR. If the person chosen is a current GSR, a new GSR should be elected to fill his or her vacated position. An LCM may have also had past service experience as a GSR or DCM, or have had other District committee Chair experience.

In addition, all candidates for all positions should have had a substantial period of continuous sobriety in AA (generally four or five years) and have had experience in service work at the group and District levels. Persons nominated for election shall be present at the meeting to confirm acceptance of the nomination prior to voting.

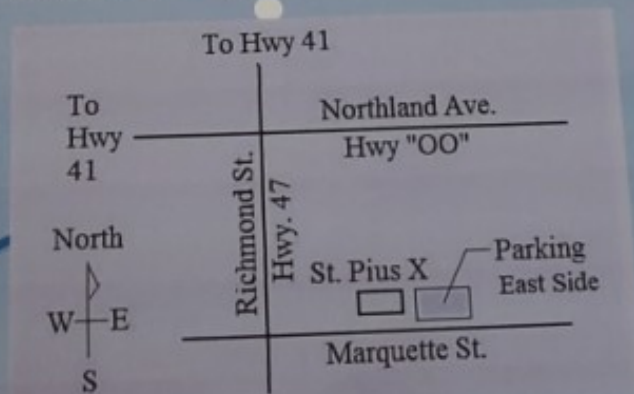

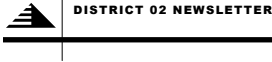
