Corrections: Noonday. All Winnebago County Corrections AA Meetings have been suspended due to the increase of Covid. We are still accepting volunteer applications to fill positions once facilities reopen.

Bridging the Gap: Mike. Placed four male inmates, two out-of-town and two in-town. Jeff requested to transfer PO Box. The Department of Corrections has shut down outside visitors.

Treatment and Accessibilities: Rita. Looking for volunteers for 12-step calls for people in treatment centers. Forms were given to GSRs or you can stop in or call the FVCO.

Public Information: Barry. My name is Barry and I am an alcoholic. The PI committee met on December 16, 2021. We had 6 members in attendance. I continue to try to ascertain the whereabouts of the PI display that was used at events such as intergroups, service workshops, etc. We probably will have to start from scratch and construct a new one.

The newly formatted District 2 information/hotline cards have arrived. Cards were distributed to the PI committee members present. I have brought cards with me today if anyone would like some. I ordered 1000 cards initially and will reorder as needed. Cards now contain both the Appleton and Oshkosh hotline numbers. I also purchased some plastic card holders for locales where we can display a larger number of cards.

The committee began brainstorming ideas for how we can best serve the general public both in the short term and in the long term. District 2 information/hotline cards will be distributed by the committee to locations such as local businesses with bulletin boards, libraries, emergency shelters, Valley transit, grocery stores, Goodwill, YMCAs, etc. Other ideas tossed around were making sure the Big Book & Living Sober are in local libraries. Committee members were assigned libraries to investigate. A first draft letter has been composed to mail to schools offering Alcoholics Anonymous services, probably a Post-Covid activity. We will look into a workshop/luncheon for healthcare professionals to offer information and answer questions. This is a long-term goal. We also look to staff a booth at health fairs of organizations such as FVTC, health organizations, etc. There is a Recovery in Our Community event on March 30 at UW Oshkosh. I have contacted them to see if we can staff a booth at this event. Other potential networking events are the county fairs in District 2 (Outagamie, Calumet, and Winnebago). We have the dates for these events and will look into staffing a booth. Lastly, we discussed the possibility of creating a Facebook page to disseminate information to the public about Alcoholics Anonymous. We decided that this idea should be discussed within the groups of District 2.

Old Business

The open positions of LCM-B, LCM-D, and LCM-E, as well as that of Newsletter Chair, were carried over. Barry nominated Char V. for Archives Chair. She accepted and was voted in.

Reviewing equipment/quote to hold hybrid District meetings was carried over as the committee was not all present to go over what they found.

New Business

Past Delegate Char V. explained the process for the changes in the 12 and 12. The concern was that people were not aware of these changes. She mentioned that the GSO had gotten many letters claiming people were not aware. Char served on the Literature committee at the General Service Conference via ZOOM. The Literature committee met ahead of time to discuss how to tackle the agenda items. She said both changes were discussed. There is a big push in the fellowship to be more inclusive to all people. The change on page 117 from "opposite sex" to "partner" was passed with 112 in favor and 19 apposed. The change on page 66 from "No one wants to be angry enough to murder, lustful enough to rape, or gluttonous enough to ruin his health" to "No one wants to commit the deadly sins of anger lust or gluttony." There was a motion to reconsider which was passed and went back to the conference and passed with 88 in favor and 41 apposed. Char stated that the cutoff date for agenda items was moved from December 15th to September 15th. There is currently a motion to discuss the changes in the 12 and 12. Char encouraged members to attend the Delegates Workshop where the agenda items are talked about and any AA member can attend.
