The PI committee had its foundational meeting on November 18, 2021. We had 6 members in attendance. Amanda C. was elected as recording secretary. Thank you, Amanda, for your willingness to serve. I had done an initial inventory of PI items passed on to me. Subsequently, I added some pamphlets and other items I had accumulated during my work with area CPC. I have also made an initial dialogue with the PI desk at GSO and have a contact, which may change with the New Year. I did recently receive a copy of the PI Workbook that our committee can use.

I am still trying to ascertain the whereabouts of the PI display that was used at events such as Inter-groups, service workshops, etc. We may have to start from scratch and construct a new one.

At our first meeting, we discussed producing a business card that could be attached to bulletin boards, etc., all over the district with information on how to contact us. This will serve as the new hotline card as it contains both the Appleton and Oshkosh hotline phone numbers as well as the Web address for the District. The card is bilingual with both English and Spanish. These cards have been ordered and are on their way. I am today submitting a receipt for \$52.85 for the cost of these cards and a receipt for \$11.08 for copies, for a total of \$63.93.

Copies of the Public Information guidelines were distributed to the members present. Members were asked to read the guidelines and familiarize themselves with how Public Information committees can serve. We will be discussing the guidelines and will brainstorm service ideas at our next meeting.

Years 2020 and 2021 in review

- With the help of many, created and implemented ZOOM protocols; hosted 4 meetings per week; helped many local and area groups set up their own meetings; and initialized the updating of the District 02 Website so people could find online meetings as the world shut down because of the COVID-19 pandemic.
- Laid the groundwork for regularly scheduled American Sign Language meetings within District 02.
- Made or maintained contact with 15 Treatment facilities within District 02.
- Updated facility contact information, inventoried pamphlets, etc., at each location, and did a needs assessment survey of each.
- Began the process of creating a workshop for facilities based on their needs.

T/A Kim R. nominated Rita R. as the Chair for 2022-2024 and Lori seconded. Rita accepted election.

New Business

Approved Budget: T/A budget was adjusted to \$1530 after the line item ZOOM was added to the budget from the DCM budget. The Newsletter budget was adjusted to \$1670 from the old budget of \$1910 with the removal of the line of postcards, stamps, labels, and misc. (\$240). Barry made a motion to approve the amended budget with the changes. Kim R. seconded the motion. Motion carried.

Discussion on future meetings. The majority of the discussion was to hold the District meetings hybrid with the equipment that was in the discussion. The cost of the equipment can range from \$750-\$1000. Kim R. and Trevor agreed to look more into the cost and the needs for the equipment and will bring the information to the January 2022 District meeting.

January 2022 meeting change: Lori motioned to change the date to January 16th, and the motion was seconded by Kristin. Motion carried.

Adjournment

A motion to adjourn was made by James and seconded by Noonday. Motion carried at 3:42 p. m., and the meeting closed with the Responsibility Declaration.

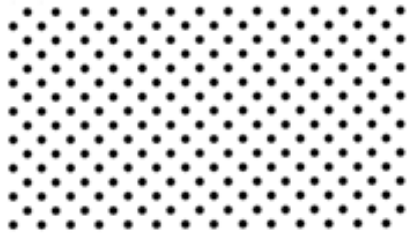

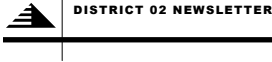
