On April 1st, we held our last Correction Committee meeting at the Genesis Club to discuss the state of corrections in District 02. Eight of us attended, which is one of our best-attended meetings since I started in this role.

Please join us at the next corrections committee meeting on June 10th at 11:00 AM at the Genesis Club in Appleton.

We reviewed our seven facilities in District 02 and found that we have enough supplies except for the Winnebago County jail. We are waiting on an order of small Big Books from the central office. If anyone has any immediate needs, please get in touch with me directly.

We now have a flyer (see attachment) shared at the district meeting yesterday, as volunteers continue to be our most significant need. Please share this flyer at your meetings. (Our flyer did not make it to the May newsletter, but I will make sure I get it to the next one.)

We talked about our current funds of \$993.27, a possible future workshop, and our correction literature budget. The correction literature budget was spent down to \$113.89 before prices increased.

Old Business:

Card distribution update - Committee members continue distributing cards to district businesses and institutions.

Recovery Fest is 9/10/2023 at Solutions. We will again staff a booth at the event.

PI example, Facebook pages were distributed to GSRs and Committee chairs. These will be discussed and voted on hopefully today.

We also plan on doing another round of Little Lending Libraries to replace Grapevine magazines that have been borrowed.

We are also considering doing the same at doctor's offices where magazines are allowed into the facility. We are waiting for a little warmer weather to perform this work.

Another project would be to put Hotline cards in hotels, motels, and some businesses in the district.

I have heard from 2 of the 3 fairs in our district. I have filled out and applied for the Winnebago County Fair to be held August 2-6 in Oshkosh. I created a Signup Genius for volunteers who would like to staff the booth and will provide the link to sign up shortly. We will be hosting in 3-hour increments (9-noon, noon-3, and 3-6, except Sunday, which will not have the 3-6 PM slot. I have contacted the Calumet County Fair and will receive the application in the mail shortly. That fair is held on Labor Day weekend (September 1-3 (Friday thru Sunday).

New Business:

The committee voted to continue to hold our meetings via Zoom. I am still seeking an individual willing to stand for the Public Information chair for District 2 for the next rotation. Anyone willing to stand, please get in touch with me.

Old Business

Open positions - LCM E, LCM F and Archives. There were no nominations and these positions carried over.

It was emphasized that GSRs were expected to bring the example pages of the Facebook mock-ups. The committee clarified that the Facebook page was purely informational and prohibited posting. Additionally, the like button may be removed. Mike raised concerns about another District 02 page already existing and whether it would need to be clarified for people. In response, Trevor explained that our page was more of an informational page than a private one where people could post. The committee agreed to contact the owner of the existing page to see if it could be taken down. Amanda motioned that the Public Information Committee proceeds with publishing the Facebook page as presented in the April Newsletter, which is purely informational. James seconded the motion, and it was passed.

The Guidelines for Consideration

1. Definition of Terms

District Committee Member Currently reads: District Committee Member (D.C.M.) is defined in the A.A. Service Manual as follows: "He or she is a G.S.R. elected by the other G.S.R.s to represent the groups of their district in area committee meetings and coordinate service activities in the district. Suggest replacing it with "The heart of A.A. is the group, which elects a general service representative (G.S.R.). The G.S.R. attends district meetings that are made up of the groups in that district. The G.S.R.s elect a district committee member (D.C.M.). Thus, the D.C.M. is the vital link between the group's G.S.R. and the area service structure, including the area's delegate to the General Service Conference." From the A.A. Pamphlet Your D.C.M. F-12 Reasoning: Original content is no longer valid.

2. Article III: D.C.M., L.C.M.s, and District Officers and Duties, Section 1.00

Currently reads: The duties of the District Committee Member (D.C.M.) and the Alternate D.C.M are described in Chapter 3 of the A.A. service manual. Update to read: The duties & responsibilities of the District Committee Member (D.C.M.) and the Alternate D.C.M are described in the A.A. Service Manual. Reasoning: Chapters in the A.A. service manual can change. This leaves it general yet directs us to the A.A. Service Manual resource.

3. Article III: D.C.M., L.C.M.s, and District Officers and Duties, Section 6.00

Currently reads: The L.C.M.'s job is a two-way communication link between the District and the G.S.R.s in the Local Committee Members' sub-districts, and the L.C.M.s are responsible to the D.C.M. The L.C.M.s regularly attend all district meetings. They receive reports from the groups through G.S.R.s and frequent personal contact with groups in their sub-districts. They may hold special meetings of all G.S.R.s in their subdistricts. They help the D.C.M. cover the District, which would be impossible for the D.C.M. to do on a group-to-group basis. They provide groups with "Group Change Forms" and generally assist the D.C.M. in obtaining group information. They keep the groups and G.S.R.s informed about District activities and make sure that G.S.R.s are acquainted with The A.A. Service Manual, Twelve Concepts for World Service, the G.S.O. bulletin, Box 459, the Twelve Traditions, workbooks and guidelines from G.S.O., and other service material. They help the G.S.R.s make reports to their groups and encourage them to bring new A.A. members to district service events. They keep groups informed about Conference-approved books and pamphlets. They regularly keep in touch with the D.C.M. and bring Traditions problems to the attention of the D.C.M. They also regularly practice talking to groups, new and old, about the responsibilities of general service work and its rewards, as well as helping groups elect a G.S.R. and other service positions. The L.C.M.s assist new groups with A.A. catalogs, recommended literature, and books. L.C.M.s also help the groups develop a well-informed group conscience on matters affecting the group or A.A. as a whole, encouraging the use of A.A. Traditions and Concepts to achieve harmony. Update to read: "The L.C.M.'s job is primarily that of a two-way communication link between the District and the G.S.R.s in the Local Committee Members' sub-districts, and the L.C.M.s are responsible to the D.C.M. The L.C.M.s regularly attend all district meetings." Reasoning: each D.C.M. is different in the way they facilitate the District. If we list these in the guidelines, then we are limiting flexibility. Second, the A.A. Service Manual offers suggestions on Role & Responsibilities for D.C.M.s, listed in the service manual, are common, but not all districts take on all those tasks. Third, L.C.M.s should not replace the voice of the group, the G.S.R., reporting back on the G.S.R.'s/Group's behalf.

4. Article I: Membership; Section 2.00 Voting Membership; Section 2.04

Currently reads: L.C.M.s are each afforded one vote. Update to read: L.C.M.s are non-voting members of District 02 Reasoning: If the L.C.M.s report to the D.C.M., their vote is duplicated and could interfere with G.S.R. votes at the district level. The L.C.M.s should not replace the voice of the group, the G.S.R.

Printed Newsletters - Tabled

New Business

Budget - Kendra said that committee chairs should review their budgets periodically throughout the year. This helps determine if committees require additional funds and if the allocated budgets are effectively utilized. Kendra emphasized the importance of transparency with groups by informing them about how the District spends its donated money.

Lastly, please mark your calendars for the next District meeting on Sunday June 11th, 2023, at Prince of Peace Lutheran Church, 2230 E Calumet St. Appleton WI.


