DCM: Jane, On Feb 8 I went to Green Bay for the GSR Orientation. Two wonderful GSR's from District 02 were also there! Here are some of my notes:

1. Homegroup business meetings, district meetings, area meetings and the business done at World Services in New York are all theoretically run the same way. (That makes it easier for me, I like to Keep It Simple!).

- 2. It's really OK to ask questions of folks who have experience in service. Ask for Help!
- 3. When people complain, ask what they're doing to help out.
- 4. READ THE AA SERVICE MANUAL great information on what to do as your job and what to read!
- 5. Get a service sponsor. It can be your regular sponsor if they have service experience. ©
- 6. Check the <u>aa.org</u> website for GSR materials including the GSR kit which can be downloaded.
- 7. The GSR should be at most group, District and Area service meetings. Otherwise, the Alternate or a designated back-up person so your group can have a voice and a vote.
- 8. It's really important to bring info from AA to your group and from your group to the rest of AA. It helps us all be involved unity, you know? Take for example, the changes that were made in the 12 and 12 and the preamble. I hope your group had a voice in those decisions.

I visited a few groups. One group needed help with an issue regarding new folks who were feeling unwelcome. We referred to the experience of other groups and also to some of our AA literature for some suggestions.

I've been working on trying to contact all active GSR's in the district. Going through a lot of paperwork.

Newsletter: Totally electronic? Eliminate \$18 fee for flyers?

Amendments for Considerations that were presented at the December 2023 District 02 meeting, were also presented at the February 2024 District 02 meeting. Below is the amendment to the guideline which was read in full at this meeting.

Article VIII: Amendments to the Guidelines, Section 1.00 - The Guidelines may be amended at a District Meeting by a two-thirds majority vote, provided that the amendment been presented in writing at the two previous District Meetings.

1. Article IV: District Standing Committees and Duties, Section 5.00 currently reads:

The District 02 Newsletter Committee is the medium for communication of District 02 business and events to the groups, G.S.R.s, and individual members. The Newsletter is published the monthly and the editorial staff is responsible for determining the content of each issue. All content/events must be AA-related. There is an \$18 charge per single-sided flyer, other than for events hosted by District Committees and District Officers. The Editor will inform the Treasurer of money that is to be collected from a Non-District AA-related flyer. The Editor shall request appropriate funding from District 02 to meet the costs of publication and submit reasonable documentation to the Treasurer for reimbursement. The Editor shall also submit an annual budget to the District for the upcoming year The Chairperson or a delegate representative provides monthly reports at District Meetings.

# Change this section to read:

The District 02 Newsletter Committee is the medium for communication of District 02 business and events to the groups, G.S.R.s, and individual members. The Newsletter is published electronically monthly and the editorial staff is responsible for determining the content of each issue. All content/events must be AA-related. The Editor shall request appropriate funding from District 02 to meet the costs of publication and submit reasonable documentation to the Treasurer for reimbursement. The Editor shall also submit an annual budget to the District for the upcoming year. The Chairperson or a delegate representative provides monthly reports at District Meetings.

Background-Traditionally the newsletter was printed and mailed to subscribers. Over the past two years there has only been one request. The past two months, District 02 has not printed newsletters for distribution. Charging groups \$18 to submit flyers was introduced to offset the additional costs for printing and postage – if produced electronically, there is no need to charge groups this fee. In reaching out to other districts and Area 74, the majority are providing electronic versions with option to receive a printed copy if required/requested.

After discussion at the district meeting and feedback from AA groups, we are submitting guideline changes. (Changes presented at 12/10/23 district meeting & presented at 02/11/24 district meeting).

GSR's should take this information to their groups and have discussions and bring feedback to the March District meeting. If there are no changes, the Amendment for Consideration will be voted on at the March District meeting.

Dale says there are people that don't have the ability to print or have a way to receive the newsletter. In favor of keeping the subscribe option.

Kim-her understanding was that all of the subscriptions had run out.

Jodi – each group has autonomy to print the newsletter or provide a service to provide the newsletter.

GSR Orientation – Jane skipped over this. She will add the notes she took at the workshop to the newsletter.

Founders Writings GSO Letter & Questions – There was some misunderstanding. The Trustees in NY, miscommunicated information. The answers to the questions should not be sent to GSO. Group change forms GSR – new GSR's, please fill out the form

Treatment & Accessibilities ASL Issues Regarding Funding -Jodi shared the background information. The following is taken from an excerpt written by Kim, Committee Secretary. Prior to January 2021: The initial ASL meeting discussion began in late 2019 early 2020 as Area 74, individual Districts within Area 74 & AWS were all engaged in conversations about how we can best support the deaf communities. In March 2020 the District 02 T& A Committee primary focus shifted to supporting the fellowship with online meetings during Covid. ASL research, conversations & reports to District 02 have continued. District 02 voted & approved that the T & A Committee should continue to move forward with plans to host signed ASL meetings within the District. In April 2021 the District body was asked to decide how the ASL meetings should be funded. Would they be a line item on the budget, or should they be funded through a special collection dedicated strictly for ASL meetings. The T & A Committee was asked to provide GSR's with information to take back to their home groups so they could weigh in how the ASL meeting would be funded. In May 2021 Kim provided a flyer for the District GSR's to take back to their meetings. It doesn't appear that a vote was ever taken on how the meetings should be funded. Planning & conversations continued within the committee. In October 2022, with the District approval, the committee contacted the Friday Night Kaukauna Group, Sunday Night First Things First meeting & the Sunday morning St. Elizabeth's meeting to see if they were interested in being the host facility. Two of the three groups responded. The committee voted to host the open ASL meeting at the Sunday Morning Meeting at St. Elizabeth's Hospital. The location of the meeting has already been approved but the method of funding needs to be brought to groups to be decided upon. As a committee we felt it would be irresponsible and perhaps damaging to AA if we were to reach out to the community to determine a need before the funding questions were answered. Once the funding method is established-budget line item or special collection-then the committee will begin community outreach to establish the need and best way to move forward. [editor's note: see flyer in this newsletter]

GSR's should discuss with their home groups how they would like ASL to be funded and bring this information to the March District meeting.

Priority right now is that we are financially solvent for this service. Kendra, in November \$3600 was presented to the district. At that time, we didn't know the need. In December the majority of District didn't approve the budgeted amount of \$3600 because it was 1/3 of the money that was in the treasury. The district is willing but feels it is costly and felt there may be alternatives. Jodi did research alternate devices for phones. She will look into this further. Harold, if a newcomer attended open speaker meetings, where would we refer them to go after they go to that meeting? Jodi, the goal is to find ways to be able help those with disabilities. Nicole, is the interpreter going to be licensed? Is there a consideration for accommodating other languages? Jodi, the sign language interpreter is licensed and bound by contract to keep confidentiality. Joe, do the deaf have AA meetings that are attended? Jodi will need to research. Not a lot of support in Fox Valley. Cindy, contributions coming in to the district are about \$4000 per year.

District meeting schedules – Jane passed out the schedules. They are subject to change. Delegates Workshop March 2 – this is an important meeting to go to. Winter Assembly is March 30, GSR's get to vote at this assembly. May 18<sup>th</sup> is the Area Spring Conference & Assembly. The Assembly meetings are important to attend. October 12<sup>th</sup> Fall Assembly. The more you attend these meetings, the more sense it will make. More fun!

Motion from Tuesday Night Big Book Study Group - Jeff — We move to pay for the monthly subscription to an e-mail relay service to avoid delays and being flagged as Spam. We would propose \$75 a month max for this service. Background: we saved significant monies going to a digital only format of the newsletter. E-mails are currently being filtered as spam and need to be sent in batches. Motion was seconded by Harold. Discussion —Newsletters have been going to Spam. Joe, the experience is not good having to go into Spam to bring back. Karla, GSR's should take this information back to their groups for discussion and bring feedback to the March District meeting. Digger, the webmaster changed something & the newsletters are being sent out in batches. The January newsletter he got an alert and sent to webmaster. The Webmaster adjusted records & made authentication adjustments. Digger suggests we see what happens with the February newsletters before we make any decisions. Jeff retracted the motion.

Adjournment A motion to adjourn the meeting was made by Karla and seconded by Chris. Motion carried at 4:03 p.m. and closed with the Responsibility Declaration.

## THE THIRD TRADITION

"The only requirement for AA membership is a desire to stop drinking."

Who determines whether or not a newcomer qualifies for membership? Do we set up committees to determine who can join and who can't? No, the newcomer himself is the only person that can make that decision and we have to take his word for it. Since the only requirement for membership is the desire to quit drinking, and that doesn't have to be said aloud by the newcomer, none of us has the right to deny anyone membership in A.A.

I had a problem for quite awhile with people coming to meetings and announcing that they were chemically dependent, a drug addict, dually addicted, or some other term currently in fashion at the local treatment centers. I've come to realize that my attitude about this is in direct opposition to Tradition Three.

There are no such negative requirements in this tradition such as you must also not be a drug addict etc. If the newcomer is at an AA meeting, no matter what label he puts on himself, I have to accept that he has a desire to quit drinking. Of course, I could get all upset about it and start questioning and complaining but if I read the Third Tradition it's really pretty simple. I have no right to question anyone else's motives. AA was there for me when I needed it and it'll be there for others if each of us tries to live our lives by the 12 Steps and 12 Traditions. Concentrating on people who don't belong in AA meetings is a self-defeating prospect for me. I don't have to concentrate on my own character defects then and I get to indulge in one of my favorite old behavior patterns – justifiable anger. Tradition Three does not say – The only requirement for membership is a desire to stop drinking and *Janes approval*. Jane W.

The Third Tradition (Long Form): Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought AA membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an AA group, provided that, as a group, they have no other affiliation.

#### A TENTH STEP FROM THE TRUSTEES' LITERATURE COMMITTEE

We appreciate and thank all who took the time to discuss the "proposed" questions and provided sharing. However, we realize that for the vast majority, our correspondence was unclear as to its intent and that caused confusion. We apologize for this confusion.

The November 13, 2023, correspondence enclosing "proposed" questions was not intended to be a "survey." Instead, we hoped the questions would spark discussions at the local level. And that the local sharing would be provided to the Area Delegates.

However, in a subsequent meeting with the delegates, it was stated that the sharing could be forwarded to the General Service Office. As a result, many in the Fellowship sent us individual letters relating their viewpoints on the matter.

We realize now that this invitation confused matters and inadvertently circumvented the Conference process wherein the Area Delegates bring to the Conference the sense of their respective Areas.

We have gathered the sharing received and will provide this sharing to the regional trustees who will in turn distribute to the Delegates in their Region. You may be interested to know that there is a sharing session planned for this year's General Service Conference on this very topic – "How Should We Treat Writings by A.A.'s Founders." To be clear, this is just a sharing session – not a voting or policy making discussion.

While we admittedly missed the mark with the November 13 correspondence, one silver lining is that members are discussing this important subject. We hope you continue to discuss in your local areas and connect with your Area Delegate. 
